

# Election signs



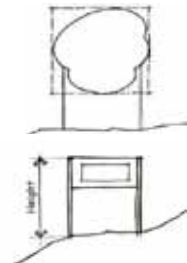
This information sheet summarises the election sign requirements that apply in the Waikato district.

Election signs must comply with the standards and terms of the relevant zone in the Waikato District Plan. If an election sign does not comply then a resource consent must be obtained from the council.



## ■ Definitions

- **Sign** - a display or device intended to attract attention and includes those affixed to, painted on or incorporated within the design of buildings. It includes any structure that supports the sign.
- **Sign area** - the area of the sign visible from one direction, and in the case of an irregular shaped sign, means the area of a rectangle that could enclose the sign.
- **Sign height** - the vertical distance between any part of the sign and its supports, and natural ground level immediately below that part of the structure.



## ■ Zone rules

The following table is a summary of the relevant rules for each zone. Please refer to the Waikato District Plan available on our website for further information, or to determine the zone in which you wish to erect your sign.

**Please note:** There are no specific designated areas for election signs to be erected in the Waikato district. Election signs are not permitted in the Recreation Zone.

Election signs are permitted in these zones providing they meet the criteria of the rules:

Does not exceed an area of 3m <sup>2</sup> for one sign per site, and 1m <sup>2</sup> for any other free standing sign on the site	x	✓	x	✓
Is set back at least 5m from the boundary of the Living Zone	x	✓	x	✓
